My Commitment

- By signing below, I understand that I am making a commitment to 100 Men of Oshawa to an annual donation of \$400 (\$100 by cash or cheque at each of the four meetings every calendar year).
- These donations will be provided directly to the "Charity of Choice" (*charity selected by majority vote of members attending and proxy votes received*) at each quarterly meeting following presentations from three charities.
- I agree to fulfill my donation commitment to the Charity of Choice announced at the meeting, even if I did not vote for that particular charity.
- If I am unable to attend any meeting, I will still fulfill my commitment by providing my proxy and donation by cheque or e-transfer to another member PRIOR to the meeting. I may also arrange directly with 100 Men of Oshawa by email at info@100MenOshawa.ca.
- In the event of my absence, it is MY obligation to ensure my donation is provided to another member in advance of the meeting.
- Should I miss two consecutive meetings without meeting my donation commitment, my name will automatically be removed from the member list. I understand that I can re-join when I am prepared to renew my commitment.
- This commitment will continue beyond the initial commitment of four meetings, until such time that I advise otherwise by email or letter.

Personal information is collected directly from members through Member Commitment forms, photographs taken at meetings or as needed to ensure data accuracy. The collected personal information (listed below) is used for group administration tasks such as meeting notification & announcements, upcoming event or overall group promotion activities and for attendance purposes.

100 Men of Oshawa shares member contact information with "Charities of Choice" for the sole purpose of processing official tax receipts as mandated by CRA. Charities of Choice have agreed to use this shared personal information for tax receipt purposes only. Any further contact with the Chamber of Choice must be initiated by the member directly.
